



# CHEROKEE COUNTY 4-H WHIZ BANG BUCKLE BLAST

March 5, 2016, at Rose City Flying Clays in Tyler, TX. This shoot is limited to the first 100 registered 4-H shooters for American Skeet, Trap, Whiz-Bang, and Sporting Clays, as well as 40 registered 4-H shooters in the Novice Division. Registration will start at 7:00 AM, Safety at 7:30 AM, and shooting will start at 8:00 AM.

**Registration is also available on iClays.com. Deadline for registration: Feb 26, 2016. Registrations received after Feb 26, 2016 will be charged a late fee in the amount of \$25.00.**

**Award Presentation:** Custom Belt Buckles will be awarded to HOA and Runner-up in each division (Junior, Intermediate, Senior I and Senior II) and also one Ladies HOA Buckle. To qualify for HOA the shooter must participate in all four disciplines. All disciplines will place 1<sup>st</sup> – 5<sup>th</sup> places. Novice I and Novice II will place 1<sup>st</sup> – 5<sup>th</sup> place with awards – No Novice HOA. We are offering an extra event, *Team Sporting Clays*. To enter this event, an adult may register with the 4-H member to become a “Team”, the 4-H member’s Sporting Clay score will be combined with the adult shooter’s score for placement. Team Sporting Clay awards will be given for 1<sup>st</sup> – 3<sup>rd</sup> places.

**Payment:** Payment by cashier’s check, money order, or personal check made payable to Cherokee 4-H Shotgun Boosters. When paying by personal check, any returned check will result in cancellation of the entry/entries that the check was paying for. To re-enter you must pay a \$30.00 return check fee. This option will only be available if there is open space remaining.

**Return Policy:** Refunds minus a \$25.00 registration fee will be made to any shooter who cancels before Feb 19, 2016. NO refund will be made for cancellations or no shows after Feb 26, 2015. All requests for refunds must be received in writing by one of the following methods, e-mail or U.S. Mail at the address provided below. All refunds will be processed and mailed **after** the tournament is completed.

**Tie Breakers:** Any ties in the Sporting Clays event will be decided by a Station Tie Breaker. All other events will have the tie settled by a shoot off.

**Parent/Coach on fields:** No coaching will be allowed while the youth shooter is on the field or in the cage during events. For safety reasons, parents will not be allowed on the skeet or trap fields. Failure to adhere to this rule will result in the disqualification of the youth shooter affiliated with that adult for that event. During

Whiz Bang and Sporting Clays events, all spectators, parents, and coaches will maintain a respectable distance from the shooting cages to allow the referee room to officiate the match. At no time may the parent, coach, or spectator interfere with the duties of the referee. Failure to respect this will result in the disqualification of the youth shooter affiliated with that spectator, parent, or coach. Continued failure to adhere to these rules will result in the expulsion of the parent, coach, or spectator.

**Shooting Carts:** Shooting carts may be used at this complex for sporting clays. Anyone driving recklessly in a shooting cart will be asked to park the cart until the end of the shoot. No exceptions.

**4-H Enrollment:** This is a 4-H event; therefore all entrants must be members of Texas 4-H Club for the current year.

**Protest Procedure:** Protests should be initiated immediately to the field referee and can only be initiated by the shooter. No protest will be accepted from parents and/or coaches.

**Code of Conduct:** The current 4-H Code of Conduct will be enforced both on and off the field during this event. Shooters, volunteers, family members or observers may be expelled from the event, match or grounds for failure to comply. Shoot management reserves the right to refuse future registration to any shooter who does not comply with the current 4-H Code of Conduct.

**Shooting Agreement & Waiver of Liability:** Please fill out and return the Shooting Agreement and Waiver of Liability form and return with the registration form. Each shooter (youth and adult) will need to sign the attached waiver. Your registration will not be processed unless all forms are returned together.

**Directions to Rose City Flying Clays:** From junction of US 69 N on Tyler Loop 323.

1. East on Loop 323 take the 2<sup>nd</sup> left past the railroad tracks. There will be a large Rose City Flying Clay's sign next to Texas College Road.
2. Turn north on Texas College Road and go approx. 1 mile past a double "S" curve sign and on approach to the 2<sup>nd</sup> double "S" curve sign. A second Rose City Flying Clay's sign is on the right and marks the gate and driveway into the clubhouse.
